## Service Contract

This contract is designed to outline services rendered by Hawks Janitorial Contracting L.L.C., hereafter referred to as "The Company", for Tooele County Public Buildings; hereafter referred to as "The Client" for janitorial and cleaning services. Following are the terms of the agreement:

- The Company shall provide cleaning services 4 times each week. Cleaning services are scheduled for Mondays, Tuesdays, Wednesdays, and Thursdays of each week. Cleaning services can be completed any time after the close of the business day and prior to the start of the next business day.
- The Client must provide access to the building for The Company.
- The Company will clean the following each time: entry way door glass, restrooms, vacuuming, dust mop, wet mop, drinking fountains, and dusting which doesn't include employees personal space. Other items can be cleaned by request and could be subject to additional charges.
- The Company will provide the following equipment for the services: vacuums, dust mops, wet mops, mop buckets, chemical for floors, micro fiber towels, chemical for dusting, paper towels for glass cleaning, chemical for glass cleaning, bowl cleaner, bowl brushes, and gloves.
- No other supplies will be provided by The Company. The Client is responsible for restroom paper products and any other items used in the facility.
- The Company will guarantee licensing and bonding.
- The Client agrees to pay the amount of \$5000.00 per month for services rendered. There will be two invoices each month in the amount of \$2500.00. Make checks payable to Hawks Janitorial Contracting L.L.C.
- This is a standing agreement that shall remain in tacked starting July 1, 2011 until July 1, 2013.
- There shall be a thirty day clause for both The Client and The Company which can terminate the contract, but only with a warning and probable cause for termination. If a warning and probable cause is given then The Client or Company must provide a written notice thirty days prior to termination.

This Agreement shall be governed by, construed, and enforced in accordance with the laws of the state in which the Property is located.

If any portion of this Agreement shall be declared invalid or unenforceable, the remainder of the Agreement shall continue in full force and effect.

It is understood and agreed that The Client hereby agrees to indemnify and save harmless The Company from and against any and all claims, losses damages, injuries or other liabilities arising out of its acts, omissions of negligence in the performance of The Client obligations under this agreement.

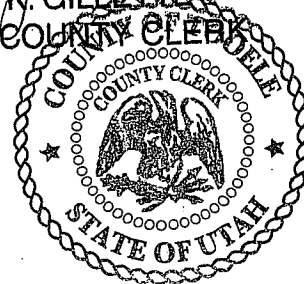
