COOPERATIVE
CORRIDOR PRESERVATION and ACCESS MANAGEMENT
AGREEMENT

THIS COOPERATIVE AGREEMENT, made and entered into this 26 Day of May, 2011, by and between the **UTAH DEPARTMENT OF TRANSPORTATION**, hereinafter referred to as **UDOT**, and **TOOELE COUNTY**.

WITNESSETH:

WHEREAS, to facilitate traffic flow along the SR-36 corridor at the intersection of the proposed South Mountain road, that will intersect SR-36 near mile post 51.0 on SR-36, in Tooele County.

WHEREAS, the **UDOT** and **Tooele County** desire to manage the corridor traffic flow and access management at the location of the new intersection of South Mountain Road and SR-36, and the South Mountain Road is to be constructed in phases, the parties hereto desire to designate specific access management and corridor preservation elements; and

WHEREAS, the **UDOT** has determined by formal finding that regulation of intersection and access points for future highway improvements is not in violation of the laws of the State of Utah or any legal contract with the **TOOELE COUNTY**.

THIS COOPERATIVE AGREEMENT is made to set out the terms and conditions hereunder said rights of way shall be preserved.

NOW THEREFORE, it is agreed by and between the parties hereto as follows:

- (1). To facilitate traffic flow along SR-36 at the location of the proposed South Mountain road near mile post 51.0 in Tooele County, Utah the parties hereto agree that the proposed improvements and procedures noted below will be undertaken:
- (2). A southbound deceleration lane (right turn) onto SR-36 will be constructed with the issuance of the permit for initial phase of the construction of the South Mountain Road.
- (3). The access granted with this agreement by the UDOT along SR-36 for the South Mountain Road will be illuminated.
- (4). In order to promote safety and efficiency along the SR-36 corridor at the location of the proposed South Mountain Road access to SR-36. UDOT and Tooele County agree jointly to limit the additional development of land served by the South Mountain Road. No other development or access will be allowed by Tooele County along the initial phase of South Mountain road until UDOT and Tooele County have reviewed the proposed development to determine whether additional improvements are required at the intersection of South Mountain Road and SR-36. Additionally, Tooele County agrees to provide additional improvements at the intersection of SR-36 and South Mountain Road as South Mountain Road is extended further to the west.
- (5). Based on future considerations and needs, this Cooperative Corridor Preservation and Access Agreement may need to be amended from its original form and, therefore, any desires to amend this agreement shall require the concurrence of both agencies.




