**A RESOLUTION OF THE GOVERNING BODY OF THE DESERET  
PEAK SPECIAL SERVICE DISTRICT ADOPTING THE FISCAL YEAR  
2017 FINAL BUDGET**

**WHEREAS**, Utah Code Annotated, Section 17B-1-614 et seq. requires the Deseret Peak Special Service District to adopt by resolution its 2017 fiscal year final budget on or before the last day of the fiscal period which is December 31, 2016, in Tooele County; and

**WHEREAS**, the tentative budget and all supporting schedules and data were available for public inspection during business hours for at least seven (7) days prior to the public hearing on the adoption of the final budget as required by Utah Code Annotated, Section 17B-1-608; and

**WHEREAS**, pursuant to Utah Code Annotated, Sections 17B-1-609 and 17B-1-610, a public hearing on the adoption of the final budget was regularly noticed up and conducted by the Deseret Peak Special Service District on December 20, 2016;

**NOW, THEREFORE, BE IT RESOLVED BY THE DESERET PEAK SPECIAL SERVICE DISTRICT** that the 2017 fiscal year final budget for the Deseret Peak Special Service District is hereby adopted and fixed in the amount of \$251,000.
